- Understanding of the consequences of their learning.
- Interest in offering reasoned views about, moral and ethical issues.
- Use of a range of social skills in different contexts, including working and socialising with pupils from different backgrounds.
- Willingness to participate in a variety of social settings, cooperating well with others and being able to resolve conflicts effectively.
- Interest in, and understanding of, the way communities and societies function at a variety of levels.
- Understanding and appreciation of the wide range of cultural influences that have shaped their own heritage.

## PURPOSE

This MOU will accomplish the above goals by undertaking the following activities:

1. Organising Capacity building programmes for entrepreneurship.
2. Voluntary involment in the organization of skill development programmes conducted by KATDC.
3. Faculty exchange programmes with KATDC as resource persons.
4. Voluntary involvement in cultural exchange programmes at KATDC.

## MEETINGS AND REPORTING / RECORDING

To accomplish these objectives, partners will meet at least three times a year for the purposes of program planning and monitoring and evaluating outcomes.

## REPORTING/RECORDING

KCE evaluate effectiveness and adherence to the agreement and when evaluation will happen and followed by recording.

It is clearly specified that, this MOU is not a commitment of any funds or financial aspects between the parties.

## TERMS OF REFERENCE OF MOU

### 1. KCE and KATDC shall jointly constitute Committee comprising of the following:

## 2. Duration

Whenever clarification is called for in respect of the clauses contained in this MOU, such matter(s) shall be referred to the Principal, KCE and President, KATDC for settlement. Both the parties hereby agree to execute the aims and objectives of MOU, within the framework of Terms of Reference of this agreement.
